2. about the registration of the order including the ordered tests.

The following payment methods are available: Direct debit (requires a German bank account), Giropay, credit cards (VISA, Mastercard), PayPal. If there is an **indication of incomplete animal data** in the email notification, please go to your user account and open the animal record in question and enter the missing data.
